Single Projects

- ➤ Individual Projects of \$250M CV or more
- > Union Projects with a PLA
- > Projects facing Non-Union Competition

Multi-Project Program or "Rolling Program"

- > Union Projects with PLAs under a single Owner or Contractor
- ➤ Individual Project Minimum value of \$75M
- Total Program Minimum value of \$500M
- > All projects start within a 3-year window from first project start
- > All projects to be completed within 6 years

- ➤ Non-Wrap Insurance and Wrap-up Max both estimated at 8% of Hard Costs
- Estimated Wrap-up Maximum Savings (No losses): \$18,417,500 (3.68%)
- Savings based on Historical ADR Wrapup Performance: \$17,267,500 (3.34%)

Achieving Maximum Credits/Alternates from Subcontractors

Education and Transparency to the Owner, GC/CM and Sub Community on the ADR Wrap-up Opportunity

- ➤ EARLY ACTION: GC/CM estimators and procurement teams requesting insurance alternates in sub bids
- ➤ Subs understanding how bids address insurance through clear written instructions and forms
- > Wrap-up Broker/Administrator as process resource
- Insurance Add/Alternate as default bid methodology
- Leveling bids with and without insurance for cost comparison create clarity on ADR Wrap-up savings
- ADR Wrap-up Pro-forma Development expertise from broker partner.

Jobsite Injury Procedures



This is an Alternative Dispute Resolution (ADR)
Program Site for Employees of PROJECT_JV
Life is Precious

For a life-threatening injury – call 911

All other injuries follow the procedures below.

What to do in the Event of an Injury

- For any injury that requires treatment, immediately report it to the Site Safety Manager and the Onsite Medical Trailer, First Care. If it is an emergency, call 911.
- 2. You will be escorted to TRAILER by a foreperson or supervisor if the situation/conditions allow.
- If you need medical treatment beyond first aid or are expected to lose time from work due to an incident, your employer will report the claim to the TPA, TPA COMPANY.
- If offsite care is required, the onsite medic will contact the Medical Provider, URGENT_CARE and your IWA, INJURED_WORKER_ADVOCATE, to begin the medical management process. You will be given billing information and directed to the Medical Provider for initial treatment.
- Prior to leaving the site, you will be provided with the ADR Injured Worker Reference Sheet and the first fill prescription card.
- If it is determined by URGENT_CARE that you are unable to return to work, you may seek treatment with an approved facility in the Medical Network, MEDICAL NETWORK.
- Follow up with the TPA, TPA_COMPANY, who will coordinate any applicable benefits or medical payments with the insurance Carrier, INSURANCE_COMPANY.
- 8. If you have any issue with the medical treatment you are receiving, contact your IWA.
- If your IWA is not providing satisfactory support, contact your Union Representative who will
 coordinate with the ADR Program Administrator, American Global LLC. Your union has
 appointed OMBUDSPERSON_NAME, as the Ombudsperson to handle and resolve your
 disputes. This service is provided at no cost to you.







- ➤ Posters to be hung in site at each jobsite trailer with instructions on how to proceed if an employee is injured
- > QR Codes will direct the worker to:
 - > Injured Worker Reference Sheet
 - Contact information for TPA, Urgent Care, Preferred Hospital, Preferred Hospital for Significant Injuries, Injured Worker Advocate
 - ➤ Medical Network
 - Link to search for doctors and/or facilities in the network for the specialty and/or region needed for the injured worker
 - > ADR Notification Form
 - Includes high level information regarding what an ADR Program is, what to do in the event of an injury, who the ADR Participants are with their contact information

ADR Program Background





ADR is a state specific legislative carveout from the traditional workers' compensation system.

Collectively Bargained on a:


- Project Basis Via PLA
- Perpetual Trade Group Insurance Basis Via CBA
- Allows for enhanced and streamlined medical care via a medical network for Workers Compensation Claims
- An alternative dispute process from the state court system

Approved and Monitored by State Workers' Compensation Authorities.

- In-network Medical Care Allows Medical Treatment to be Prioritized.
- Care Coordinators and Nurse Managers Removes Uncertainty From Claims Process
- Streamlined Medical Treatment Results in Faster Claim Resolution.
- Reduces Long-term Absence From Work and Consequential Uncertainty Surrounding Payroll Benefits For Workers and Their Families

No State Workers' Compensation Adjudication

- Ombudsperson/Arbitration: Two stage dispute prevention and resolution proactively resolves pursuits.
- ADR Does Not Impact a Worker's Legal Right to File a Lawsuit.
- Objective Medical Evidence Reduces Claims Escalation

When I arrived we got the member to the Mental Health Counselor and we were able to get some help from Crisis Services.

Our member couldn't believe that there were so many people willing to set aside whatever their day held to assist him. He was relieved to know he didn't need to deal with this alone. Ireally believe everyone involved today probably averted a catastrophic situation. Iam so thankful and appreciative of the network of help that has been made available to the hundreds of employees at the stadium project. I would also appreciate if you could share this with your team and extend my gratitude to them as well. Sometimes preparation seems like rhetoric until you actually need it.
