Statement Explanation

Contractor members bidding highway and bridge projects must be a member of the Highway Division.

You may join one or multiple CIC divisions. There is a \$270 per year supplemental dues per additional division. Check preferred membership division and pay dues accordingly.

Membership in CIC National Association ARTBA Chapter not mandatory. However, if you choose to join the national chapter CIC will subsidize 50% of the first-year national dues for current paid contractor members who also contribute to CIC Heavy Industry Advancement Funds. National Association full dues are \$650 per year for ARTBA.

Special Tax Note: Approximately 15 percent of CIC's dues income and 30 percent of national association dues income are spent to lobby local, state and national governments for beneficial laws and regulations pertaining to the construction industry. As a result of provisions of the 1993 Tax Act effective in 1994, the portion of association dues spent on lobbying are no longer a tax-deductible expense for members.

Political Action Contribution

40% of your 2026 dues payments are designated as a political contributions to the NYS CIC PAC. Please provide notice in writing to the Association if you do not wish to have this contribution made on your behalf. Please also note that Corporations and Limited Liability Companies ("LLC"), may not make total political contributions in a calendar year in excess of \$5,000. Individuals have no calendar year political contribution restrictions and are limited only to the office or entity they are contributing to. Each partner in a partnership, such as a Limited Liability Partnership ("LLP") is treated as an individual for political contribution purposes.
